Sierra Expeditionary Learning School (SELS) opened in the fall of 2010 as an independent public charter school serving 64 K-5 students. Over the first three years, SELS expanded and now serves 212 students in grades K-8. SELS offers a small school environment (class sizes from 22-25) dedicated to academic excellence, diversity, and the building of character and community. SELS is a school of choice and uses a lottery-based enrollment process. Besides running standard mathematics and literacy programs, SELS, as a member of the EL Education network of schools, focuses curriculum on thematic-based expeditions, character education, fieldwork, and the building of school-wide community and culture.

Efforts are spent regularly to reduce the achievement gap between various demographic groups.

Funding increases for academic and social-emotional support continues, primarily targeting sub-group populations: Support Teachers at K-1 and middle school; additional hours for ELD Coordinator and Counselor; elementary math RTI; and increased Reading Specialist support. These actions are being provided on an LEA-wide basis and we expect/hope that all students with less than a 100% attendance rate will benefit. However, because of the significantly lower attendance rate of low-income students, and because the actions meet needs most associated with the chronic stresses and experiences of a socio-economically disadvantaged status, we expect that the attendance rate for our low-income students will increase significantly more than the average attendance rate of all other students. (Measurable Outcomes [Effective In])
